

IMPORTANT INFORMATION

Seloka Journeys is operated by **Seloka LLC, a Maine limited liability company, United States of America.**

Seloka designs and arranges curated journeys in Southeast Asia and other destinations using selected hotels, airlines, restaurants, guides, transportation providers, chefs and experience partners.

Published itineraries, hotels, restaurants, flights, experiences, guides and other services are subject to availability and confirmation and may be adjusted when operational, safety, weather, transportation or local circumstances require. When reasonably possible, Seloka will provide an alternative of comparable quality and character.

Journey Price

The journey price includes only those accommodations, meals, transportation, activities, experiences and other services specifically identified as included in the confirmed itinerary.

International airfare to the starting destination of a Seloka Journey and from the final destination is not included unless expressly stated otherwise.

Air transportation, rail transportation, ferries and other transportation that occur **within the published Seloka itinerary** are included when specifically identified as part of the journey.

Personal expenses, travel insurance, visas, passport expenses, optional activities, meals and beverages not listed as included, and other independently arranged services are not included.

Reservations & Payment

Unless different terms are stated for a particular journey:

- A **\$750 per-person deposit** is required to confirm a scheduled Seloka Journey.
- Deposits are refundable for **14 days following booking**, provided the booking is made before the final-payment deadline.
- Final payment is due **95 days before departure**.
- Reservations made within 95 days of departure require payment in full.

Guest Cancellation

Unless otherwise stated in the specific journey terms, the following cancellation charges apply:

- **96 days or more before departure:** \$300 per person
- **61–95 days:** 30% of the journey price
- **31–60 days:** 60% of the journey price
- **30 days or fewer:** 100% of the journey price

Cancellation must be submitted to Seloka in writing.

Certain hotels, airlines, private venues or exclusive experiences may impose additional or earlier non-refundable conditions. Any such material conditions will be communicated when applicable.

Travel Insurance

Comprehensive travel insurance is strongly recommended. Travelers should consider coverage for trip cancellation and interruption, medical expenses, emergency evacuation and repatriation, travel delays, missed connections and baggage.

Passports, Visas & Health Requirements

Travelers are responsible for ensuring that they possess passports, visas, permits, vaccination documentation and other entry requirements applicable to their nationality and itinerary.

Seloka may provide general guidance but cannot guarantee entry into any destination.

Guests should advise Seloka before travel of allergies, medical dietary requirements, accessibility requirements or other conditions that may materially affect participation.

Changes & Independent Suppliers

Hotels, airlines, restaurants, transportation companies, guides, chefs and other service providers are generally independent suppliers.

Seloka may change the order or content of an itinerary when reasonably necessary. Nothing in these terms excludes or limits rights or responsibilities that cannot legally be excluded under applicable law.

International Bookings

Consumer rights vary according to the traveler's country and place of booking.

Travelers booking in the **United States, European Union, United Kingdom or other jurisdictions** may have statutory rights in addition to these terms. Where mandatory consumer or package-travel legislation applies, those rights take precedence over any conflicting provision in Seloka's booking conditions.

Full Booking Conditions

All reservations are subject to Seloka Journeys' complete **Booking Terms & Conditions**, the applicable journey description and the traveler's booking confirmation.

Seller-of-travel registration statements and numbers will be displayed where required by applicable U.S. state law.
